- 1 **Ymddiheuriadau/Apologies:** Cafwyd ymddiheuriadau gan/Apologies were received from:- Cyng/Cllrs Wyn Evans, Mrs Philippa Davies, Philip Marchant. Cyng/Cllr Mrs Carolyn Reed-Rees - cafwyd ymddiheuriad ymlaen llaw am gyrraedd yn hwyr/apology was received beforehand for arriving late).
- 2 **Datgelu Buddiannau Declarations of Interest:** Cllr Peter Davies – Eglwys Tregroes Church, Cllr Beth Davies – Eglwysi Tregroes a/and Capel Dewi Churches. Cllr Andrew Howell – Ieuenctid Tysul Youth (ond ni adawodd yr ystafell/ but did not leave the room).
- 3 **Cofnodion/Minutes:** Derbyniwyd bod cofnodion y cyfarfod misol a gynhaliwyd ar 14 Tachwedd 2011 yn gywir ac fe'u llofnodwyd gan y Cadeirydd/Minutes of monthly meeting held on 14 November 2011 were accepted as correct and signed by the Chair.
- 4 **Materion yn Codi – 3 Ciosg Coch** – cafwyd adroddiad gan Gyng Mrs Eileen Curry ynghylch y cyfarfod cyhoeddus a gynhaliwyd yn ddiweddar ym Mhren-gwyn, a nodwyd bod cynnydd yn cael ei sicrhau. Mae Ciosg Capel Dewi yn Adeilad Rhestredig a gwnaethpwyd penderfyniad unfrydol i gymeradwyo cais newid defnydd ar ei gyfer. Er gwybodaeth, adroddodd Cyng Keith Evans bod y Cynulliad wedi cadarnhau ei fod yn cefnogi'r Ysgol 3-19 yn Llandysul. Cynhelir Gwasanaeth Carolau Hen Gapel Llwynrhedowen ar 24 Rhagfyr 2011.
- 5 **Rhoddion** – Datgeliadau yn unol ag eitem “2” uchod.
 - a) **Lleisiau Bro Eirwyn** – Piano Trydan – Penderfynwyd gofyn a oes unrhyw Gynghorau Cymuned eraill wedi cyfrannu ac a fyddai modd i sefydliadau eraill fenthyca'r Piano yn ôl yr angen.
 - b) **Ieuenctid Tysul Youth** – Bydd yr eitem hon yn aros ar yr Agenda.
- 4 **Matters Arising – 3 Red Kiosks** – Cllr Mrs Eileen Curry gave a report of the public meeting recently held at Prengwyn and progress is being made. Capel Dewi Kiosk is a Listed Building and it was unanimously approved for an application of change of use to be made. For information purposes Cllr Keith Evans reported that the Assembly has confirmed their support for the 3-19 School at Llandysul. Hen Gapel Llwynrhedowen (Chapel) Carol Service is to be held on 24 December 2011.
- 5 **Donations** - Declarations as in “2” above.
 - a) **Lleisiau Bro Eirwyn** (choir) – Electric Piano – It was decided to enquire whether other Community Councils have donated and whether it would be possible for other organisations to borrow the Piano should the need arise.
 - b) **Ieuenctid Tysul Youth** – To remain on the Agenda.

- c) **Eglwys Tre-groes Church** – (gofynnwyd am £5,000). Atgoffwyd y Cyngor gan y Clerc o'r ffaith bod gennym 9/10 o Eglwysi/Capeli yn y Gymuned. Mae Capel Pantydefaid wedi cael £1,200. Mae Eglwys Capel Dewi wedi cael £1,000. Cafwyd gwybodaeth am y gwaith arfaethedig yn Nhre-groes erbyn hyn. Yn unol â chymeradwyaeth ar gyfer y gwaith i'w gyflawni, sef y weithdrefn arferol, cynigiodd Cyng Keith Evans y dylid rhoi £3,000, eiliwyd hyn gan Gyng Douglas Davies ac fe'i dderbyniwyd. (Cyrhaeddodd Cyng Mrs Carolyn Reed-Rees)
- d) **Neuadd Pont-siân Hall** – (gofynnwyd am £10,000) Bydd yr eitem hon yn aros ar yr Agenda.
- e) **Eglwys Pont-siân Church** – (gofynnwyd am £10,000) Cafwyd ffurflen wedi'i llenwi a gwybodaeth fanwl. Anfonir llythyr yn nodi y byddwn yn ystyried y mater ar ôl iddynt gadarnhau'r swm y byddant yn ei gael gan eraill.
- f) Bydd **Eisteddfod Llangollen, Bobath Cymru a Shelter Cymru** yn cael eu trafod yn ystod y cyfarfod ym mis Mawrth, ar ddiwedd y flwyddyn ariannol.
- g) Cafwyd **cydnabyddiaeth derbyn rhodd** wrth Llandysul a Phontweli Ymlaen ac Apêl y Pabi Llandysul. Roedd Canolfan Ddŵr Llandysul Aqua Centre yn cydnabod eu bod wedi cael cyfran o'r taliad, a gofynnwyd am gadarnhad ynghylch y dyddiad cau ar gyfer y gweddi. Bydd ymholiad yn cael ei wneud ynghylch eu hamserlen.
- h) Anfonwyd **ffurfleini ymgeisio am Grant** ymlaen at Ofal Cancer Marie Curie a Home Start. Penderfynwyd gofyn am bosteri er mwyn denu sylw gwirfoddolwyr posibl ar gyfer Home Start.
- 6 BDO** – Cafwyd **Hysbysiad ynghylch Cwblhau Archwiliad** ac yn ôl y gofyn, cymeradwywyd y cyfrifon unwaith eto gan y Cyngor, a hynny'n unfrydol. Bydd y datganiad blynnyddol a'r Hysbysiad ynghylch cwblhau archwiliad yn cael eu harddangos am 14 diwrnod nawr. Cafwyd nodyn yn gofyn am y ffi o £342.00 a derbyniwyd y dylid ei thalu.

c) **Eglwys Tregroes Church** – (£5,000 requested). The Clerk reminded the Council that we have 9/10 Churches/Chapels in the Community. Pantydefaid Chapel have received £1,200. Capel Dewi Church £1,000. Information has now been received regarding the proposed work at Tregroes. Subject to the approval of the work carried out, being the usual procedure, Cllr Keith Evans proposed £3,000, this was seconded by Cllr Douglas Davies and carried.

e) **Eglwys Pontsian Church** – (£10,000 requested) Completed form was received with detailed information. Letter to be sent informing that we will consider the matter after they confirm the sum being received from others.

f) **Llangollen Eisteddfod, Bobath Wales and Shelter Cymru** are to be discussed at the March meeting being the end of the financial year.

g) **Acknowledgement of receipt of donations** were received from Llandysul a Phontweli Ymlaen and Llandysul Poppy Appeal. Canolfan Dŵr Llandysul Aqua Centre acknowledged receipt of the part payment and enquired as to the deadline for the remainder. Enquiry re their timetable to be made.

h) **Grant application forms** have been forwarded to Marie Curie Cancer Care and Home Start. It was decided to request posters for attention of possible volunteers for Home Start.

Gwnaethpwyd penderfyniad unfrydol y bydd Cyngorwyr Keith Evans a Tom Cowcher yn trefnu bod y graean yn cael ei gasglu ac y bydd gorchudd/tarpolin yn cael ei brynu, y bydd y Cyngor yn talu amdano. Bydd graean ar gael i'r cyhoedd ei brynu.

Cais am Oddefeb – rhoddwyd goddefeb i Gyng Keith Evans siarad, ond nid i bleidleisio, yngylch ceisiadau am gymorth ariannol gan y sefydliadau canlynol, Ysgol Gynradd Llandysul, Ysgol Dyffryn Teifi, Pwll Nofio Llandysul, Parc Coffa, Padlwyd Llandysul, Y Pwerdy, Llandysul a Phontweli Ymlaen a'r Ganolfan Deuluo.

b) ULIC – Cafwyd gwybodaeth am y Diwrnod Ymwybyddiaeth Ewropeaidd yngylch Gwrthfiotigau, Materion yn ymweud â Hyfforddiant, Crynodeb o'r Ymateb i Adolygiad Llywodraeth Cymru yngylch Cerddwyr, Arolwg i Gynghorau Lleol gan yr Arolwg Ordnans, Rhwydweithiau Ymarferwyr Dyfodol Cynaliadwy – Cyfarfod Cenedlaethol, Rheolau Sefydlog Model a Phenodi Hyrwyddwyr Hyfforddiant. Bydd Rheolau Sefydlog yn cael eu cynnwys ar yr agenda nesaf.

8 Salt/Grit Bins

– Cllr Andrew Howell reported that the bins are ready to be sited. Grit Bins to be added to our insurance cover but, the Community Council will not be responsible for the dispersing of grit and will be there to assist the public at their own risk. It was unanimously decided that Cllrs Keith Evans and Tom Cowcher will arrange for collection of grit and purchase a cover/tarpaulin which is also to be paid for by the Council. Grit is to be made available for the public to purchase.

9 a) The following were received from

Ceredigion: - Information was received re Caeau Bach project. Information was received re Balchder Pentrefi, we will continue to try and arrange a visit. Application for Dispensation – Cllr Keith Evans has been granted dispensation to speak but not vote in respect of requests for financial support from the following organisations Llandysul Primary School, Dyffryn Teifi School, Llandysul Swimming Pool, Memorial Park, Llandysul Paddlers, The Powerhouse, Llandysul a Phontweli Ymlaen and Family Centre.

b) OVW – Information was received re European Antibiotics Awareness Day, Training Issues, Summary of Response to Welsh Government Walker Review, Ordnance Survey Local Councils Survey, Sustainable Futures Practitioners Networks – National Meeting, Model Standing Orders and Appointment of Training Champions. Standing Orders is to be placed on the next agenda.

- e) **Banc Lloyds** – Cafwyd siec am y swm o £4.04 ac fe'i talwyd i mewn i Fanc Nat West. Cafwyd cadarnhad o'r ffaith bod y cyfrif wedi cael ei gau nawr.
