Minutes of Monthly Meeting of Cyngor Cymuned Llandysul Community Council held at Canolfan Ieuenctid Tysul Youth Centre, Llandysul, on 10 October 2011

Yn Bresennol/Present: Cyng/Cllrs Tom Cowcher Douglas Davies Peter Davies Mrs Philippa Davies Wyn Evans Terry Griffiths Andrew Howell Philip Marchant (Is-Gadeirydd/Vice Chairman) Mrs Carolyn Reed-Rees a/and Breian Teifi.

Chair - Yn absenoldeb Mrs Eileen Curry galwodd y Cyngor ar Gyngorydd Philip Marchant (Is-Gadeirydd) i lywyddu fel Cadeirydd/In the absence of Cllr Mrs Eileen Curry the Council called upon Cllr Philip Marchant (Vice Chairman) to preside as chair.

Croeso/Welcome – Estynwyd croeso cynnes i bawb yn enwedig Cyng Terry Griffiths ar ôl cyfnod o salwch. A warm welcome was extended to all, especially Cllr Terry Griffiths after a period of ill health.

- 1 **Cyflwyniad/Presentation** - RAY Ceredigion – Mynychodd Cathryn Morgan y cyfarfod a chafwyd cyflwyniad byr. Cadarnhawyd bob y sesiynau chwarae yn llwyddiannus/Cathryn Morgan attended the meeting and gave a short presentation. It was confirmed that the play sessions are successful.
- 2 **Cyflwyniad/Presentation** - Ieuenctid Tysul Youth - Mynychodd Steve Parkin a Marc Folds a chafwyd cyflwyniad ynglŷn â'i bwriad i gael prosiect Celf yn y Parc/Steve Parkin and Marc Folds attended the meeting and gave a presentation on their proposed project of Art in the Park.
- 3 **Ymweliad/Visit CCTV** - Mynychodd Heddwes Dafydd Jones y cyfarfod ond eto, nid oedd y Cyng Gareth Williams yn bresennol. Penderfynwyd y bydd cynrychiolwyr yn ymweld â Gorsaf Aberystwyth i weld y system yn gweithio a bydd Heddwes Dafydd Jones yn gwneud trefniadau gyda'r Clerc i arbenigwyr i ddod i Gyfarfod Arbennig yn Llandysul/Pc Dafydd Jones attended the meeting but again, Cllr Gareth Williams was not present. It was decided that representatives will attend the Police Station at Aberystwyth to view the system working and Pc Dafydd Jones will make arrangements with the Clerk for specialists to attend a Special Meeting at Llandysul. (Cyrrhaeddodd Cyng Tom Cowcher a Breian Teifi ar yr adeg hon/Cllrs Tom Cowcher and Breian Teifi arrived at this stage)

- 5 **Datgelu Buddiannau/Declarations of Interest:** Ieuenctid Tysul Youth - Datgelwyd diddordeb gan Gyng Andrew Howell ond ni adawodd yr ystafell ar gyfer y cyflwyniad /Cllr Andrew Howell declared an interest but did not leave the room for the presentation.
- 6 **Cofnodion/Minutes:** Derbyniwyd bod cofnodion y cyfarfod misol a gynhaliwyd ar 12 Medi 2011 yn gywir ac fe'u llofnodwyd gan Gyng Philip Marchant a oedd yn llywyddu fel Cadeirydd/ Minutes of monthly meeting held on 12 September 2011 were accepted as correct and signed by Cllr Philip Marchant presiding as Chairman.

7 **Materion yn Codi** – **Canolfan Deuluoedd Llandysul** – mae prosiect **Bwyta'n Iach** yn cael ei hysbysebu'n dda ac mae'n mynd rhagddo yn dda iawn. Cafwyd adroddiad gan Gyng Mrs Carolyn Reed-Rees am y **Cynllun Diogelwch Cymunedol**.

8 **Rhoddion** –

- i) **Ieuentid Tysul Youth** – “Celf yn y Parc” Anfonwyd ffurflen ymlaen (gweler “2” uchod hefyd).
- ii) **Apêl y Pabi** – (a137) Penderfynwyd y bydd Cyng Mrs Carolyn Reed-Rees yn gosod y dorch. Cynigiodd Douglas Davies y dylid rhoi rhodd o £65 tuag at y dorch, eiliwyd hyn gan Gyng Tom Cowcher ac fe'i derbyniwyd.
- iii) **Sgowtiaid 1af Llandysul** – (a145) **Arddangosfa Tân Gwyllt** – Cynigiodd Cyng Wyn Evans y dylid rhoi £250, eiliwyd hyn gan Gyng Tom Cowcher ac fe'i derbyniwyd.
- iv) **Eglwys Tre-groes Church** – Bydd hwn yn aros ar yr Agenda.
- v) **Neuadd Pont-siân Hall** – Bydd hwn yn aros ar yr Agenda.
- vi) **Eglwys Pont-siân Church** – Bydd hwn yn aros ar yr Agenda.
- vii) **Urdd Gobaith Cymru** – Gofynnwyd i ni ystyried rhoi tuag at yr Eisteddfod Genedlaethol a'r Swyddfa yng Ngheredigion. Gwnaethpwyd penderfyniad unfrydol i barhau i roi'n lleol yn ôl y gofyn.
- viii) Cafwyd **Cydnabyddiaeth Derbyn Rhoddion** wrth **Gymdeithas Cyloch ac Ysgol Tre-groes a Sioe Pren-gwyn**.

9 **Biniau Halen/Graean** – Unwaith eto, cafwyd trafodaeth hirfaith. Mae Cynghorwyr Wyn Evans ac Andrew Howell wedi bod o gwmpas yr ardaloedd, gan farcio'r safleoedd arfaethedig. Bydd Cyng Andrew Howell yn trefnu cyfarfodydd safle gyda Cheredigion yn y lleoliadau y mae angen eu cymeradwyo. Rydym yn aros i glywed gan ULIC ynghylch yswiriant.

10 **CAVO** – Adroddodd Cyng Tom Cowcher na fu modd iddo fynychu'r cyfarfod ynghylch Trafndiaeth.

7 **Matters Arising** – **Llandysul Family Centre** – **Healthy Eating** is well advertised and the project is running very well. Cllr Mrs Carolyn Reed-Rees gave a report on the **Community Safety Plan**.

8 **Donations** –

- i) **Ieuentid Tysul Youth** – “Art in the Park” Form has been forwarded (also see “2” above).
- ii) **Poppy Appeal** – (s137) It was decided that Cllr Mrs Carolyn Reed-Rees will lay the wreath. It was proposed by Douglas Davies to give a donation of £65 towards the wreath, this was seconded by Cllr Tom Cowcher and carried.
- iii) **1st Llandysul Scouts** – (s145) **Fireworks Display** – Cllr Wyn Evans proposed £250, this was seconded by Cllr Tom Cowcher and carried.
- iv) **Eglwys Tregroes Church** – To remain on the Agenda.
- v) **Neuadd Pontsian Hall** – To remain on the Agenda.
- vi) **Eglwys Pontsian Church** – To remain on the Agenda.
- vii) **Urdd Gobaith Cymru** – We were asked to consider donating towards the National Eisteddfod and the Office at Ceredigion. It was unanimously decided to continue to donate locally when requested.
- viii) **Acknowledgements of Receipt of Donations** were received from **Tregroes School and District Association** and **Prengwyn Show**.

9 **Salt/Grit Bins** – A lengthy discussion again took place. Cllrs Wyn Evans and Andrew Howell have been around the areas and marked the proposed locations. Cllr Andrew Howell will arrange site meetings with Ceredigion at the locations for approval. We await to hear from OVW re insurance cover.

10 **CAVO** – Cllr Tom Cowcher reported that he had not been able to attend the meeting on Transport.

11 **Bancio** – Cafwyd llythyr wrth **HSBC** yn ein hysbysu nad oeddent yn ymwybodol o'r ffaith bod y gangen yn mynd i gau ar yr adeg pan oeddem yn cael trafodaeth gyda nhw. **Banc National Westminster** – Erbyn hyn, mae'r Clerc wedi llenwi'r ffurflenni er mwyn trosglwyddo'r cyfrif o Lloyds i Nat West, fe'u llofnodwyd gan y Pwyllgor Cyllid ac fe'u cymeradwywyd gan y Cyngor. Ar ôl cynnal trafodaeth, penderfynwyd buddsoddi £20,000.

12 **Gohebiaeth**:-

- a) Cafwyd y canlynol wrth **Geredigion** – Cyfarfod i'w gynnal ar 27.10.2011 – Cwestiynau i'w gofyn:- Gorchmynion Diogelu Coed (TPOs), Safon y gwaith o dorri cloddiau wrth ymyl y Ffordd, Polion BT ger Dolwallter, Coeden ger Dolwallter, trefniadau glanhau'r Strydoedd yn Llandysul, ffioedd parcio, dyfodol Toiledau Cyhoeddus, Cyllid ac Addysg yn Llandysul. Unwaith eto, tynnwyd sylw'r Cyngor at **Gronfa Adnewyddu Ceredigion ar gyfer Cynghorau Tref a Chymuned ynghyd â Cynnal y Cardi** – Bydd cynrychiolydd o Geredigion yn mynychu ein cyfarfod nesaf. Cafwyd anfoneb am y swm o £230 am gasglu gwastraff o'r parc a derbyniwyd y dylid ei thalu. Cafwyd gwahoddiad i'r Cadeirydd fynychu **Ysgol Gynradd Gymunedol Llandysul** er mwyn dathlu 40 mlynedd, a fydd yn cyd-fynd ag ymweliad Iarll Wessex. Nid oes modd i'r Cadeirydd na'r Is-Gadeirydd fynychu, a bydd Cyng Breian Teifi a Chyng Wyn Evans yn cynrychioli'r Cyngor. Mae modd gweld y **Siarter Gorfodi Cynllunio Ddrafft** ar y wefan.
- b) **ULIC** – cafwyd Y Llais. Cafwyd gwybodaeth ynghylch **Penodi Hyrwyddwyr Hyfforddiant**, bydd Cyng Andrew Howell yn cynrychioli'r Cyngor. **Cynhadledd ULIC** – cafwyd adroddiad gan Gyng Andrew Howell. Cafwyd anfoneb o £56 am y costau teithio i'r gynhadledd eleni ac y llynedd, a derbyniwyd y dylid ei thalu. Cafwyd gwybodaeth ynghylch y **Gronfa Loteri Fawr** ac roedd wedi cael ei dosbarthu. Cafwyd hysbysiad ynghylch cyfarfod Pwyllgor Ardal Ceredigion a bydd Cyng Andrew Howell yn mynychu.
- c) **Ysgol Gynradd Gymunedol Llandysul** - Cafwyd llythyr ynghylch dathlu 40 mlynedd ac ymweliad Iarll Wessex, fel y trafodwyd uchod.

11 **Banking** – Letter was received from **HSBC** informing that when we were in discussion with HSBC, they were unaware that the branch was to close. **National Westminster Bank** – The forms for transferring the account from Lloyds to Nat West have now been completed by the Clerk, signed by the Finance Committee and approved by the Council. After a discussion it was decided to invest £20,000.

An invitation was received for the Chair to attend **Llandysul Community Primary School** for the celebration of 40 years which coincides with the visit of Earl Wessex. Chair and Vice-Chairman are unable to attend, Cllr Breian Teifi and Cllr Wyn Evans will represent the Council. **Planning Enforcement Draft Charter** can be viewed on the website.

Information was received re **Appointment of Training Champions**, Cllr Andrew Howell will represent the Council. **OVW Conference** – Cllr Andrew Howell gave a report. Invoice was received for travelling for this year and last year in the sum of £56 and passed for payment. Information was received re Big Lottery Fund and had been circulated. Notice of Ceredigion Area Committee meeting was received and Cllr Andrew Howell will be attending.
