PCSO Shan Davies was present at the meeting. A warm welcome was given on her return from maternity leave. The following events had occurred in Llandysul in the following month:-

Oil theft in Gorrig Raod – she warned all the public to be vigilant as they had no leads.

Drugs – a targeting team is working in Llandysul and visits to certain people were imminent.

She also informed the meeting that if she was unable to attend that she would email the clerk with monthly updates.

 7. **Internal Control/Internal Checker**:-It was resolved that Cllr Aled Jones continues as Internal Control/Internal Checker.
 8. **Risk Assessment** Appropriate steps to manage Internal Control/Risk Assessment and review of Insurance have been taken.

Christmas Lights

The clerk had received prices from Festive Lighting to replace the Christmas Lights. As it would cost in the region of £8000 just for the lights it was decided to change the timing boxes only. It was also decided to let the Community know of what the cost would be and maybe engage with local businesses and other groups to see if they would be interested in fundraising.

Llandysul Park

It was reported that the work on the fence in the park would start soon and the park would have to shut but would be re-opened by the school holidays.

Pontsian Cllr Gethin Jones explained that a tree had fallen into the river outside Tawelfan in Pontsian. He was concerned as the bridge is a short distance away. The clerk to contact the County Council.
