- i) **Lleisiau Bro Eirwyn** (Choir) – (s145) Request for £400 was received. We were informed that they are now in a position to confirm that they wish to proceed to purchase an electric piano which will also be available to other organisations. It was proposed by Cllr Keith Evans to give a donation of £400, this was seconded by Cllr Douglas Davies and carried.

Clerk had informed that the Community Council pay for the cutting of the grass area and have previously paid for maintenance of the wooden hut. Ceredigion are currently carrying out maintenance work at the location. **Examination of the Ceredigion Local Development Plan (LDP)** – We were informed that an examination is to take place.
