**Minutes of Monthly Meeting of Cyngor Cymuned Llandysul Community Council held at Llandysul Youth Centre, on 9th July 2018**

**Llandysul Canoe Centre River Festival.** A request for £1500 was requested to help with the running costs of hosting the Festival. Councillors felt that such an event brought with it significant economic benefit to the locality and the decision was to donate the requested amount.

**Calon Tysul** A letter was received from the trustees of Calon Tysul asking for their annual donation of £4000 be given now. There were no objections and a cheque was written for the requested amount.

##### **D H Evans Memorial Hall Pontsian**

£2823 was requested to help with the costs of renovating a room for use in the Community. It was decided to be in full support of donating the requested amount on the understanding that the lottery funding grant had to be successful.
