1 **Ymweliad/Visit** –

Estynnwyd croeso cynnes i bawb i'r cyfarfod. Roedd PCSO Shan Davies yn bresennol yn y cyfarfod er mwyn rhoi diweddariad am y digwyddiadau yn Llandysul. Esboniodd bod Masnachwyr Twyllodrus yn targedu'r henoed yn yr ardal. Gofynnodd i bawb fod ar eu gwylidwriaeth ac i nodi a chofnodi rhifau cerbydau. Esboniodd hefyd y byddai ar gael i fynychu unrhyw gyfarfod yn y Gymuned er mwyn trafod atal trosedd.

A warm welcome was given to all to the meeting. PCSO Shan Davies was present at the meeting to give the Councillors an update to the events in Llandysul. She explained that there was Rouge Traders targeting the elderly operating in the area. She asked all to be vigilant and to note and take down number plate details. She also explained that she would be available to attend any meeting in the Community regarding crime prevention.

One incident of criminal damage had occurred in the High Street with no arrests having been made. Two calls for anti social behaviour had been received with youths meeting in cars in the main car park. She explained that she would be issuing anti-social warnings that may lead to arrests.

5) Matters for discussion

Memorial Park The Chairman explained that the park trustees were supportive of an additional option of placing the memorial plaque in the gate. More information would be available at the next meeting of the two options discussed.

Children's Play area

Cllr Abbey Reid expressed an interest in attending a course in Flint in April with Rospa. The course would ensure that she would be aware of the basics of looking after the Children's Play Area. The fee for the course would be £250 and also travel and hotel fees for 2 nights. Following a discussion it was decided to encourage Cllr Abbey to attend as it would be of benefit to the Community Council. It was decided that the Community Council would meet all fees and reasonable travel and accommodation costs.

A quote had been received from Abacus Cleaning with regards to inspecting the Childrens play area in the Memorial park. It was resolved that clerk make contact with Tai Ceredigion and Ceredigion County Council to ascertain whether either organisation had in-house inspecting regimes.

He reminded all of the importance of being at the meeting to demonstrate the strength of feeling at the demise of so many County Council services at Llandysul and it was hoped that there would be representation from all of the groups in Llandysul that had been affected. Cllr Peter Evans informed the meeting that the scrutiny committee would be recommending to the Cabinet that Llandysul Library could remain open if volunteers could operate it. A public meeting had been convened for the following week to discuss the matter further in the locality.
