Cllr Tom Cowcher informed the meeting also that he had sent Ben Lake MP the relevant information with regards to broadband coverage and speeds as well as mobile phone signal reception in Capel Dewi.

### **Llandysul**

Councillors expressed their gratitude to the group of volunteers that are undertaking street and litter cleaning on Llandysul streets generally on Sunday mornings and especially to Gareth Lloyd, a local businessman who is co-ordinating the volunteers.

Individuals continue fly tipping bottles on the ground adjacent to the bottle banks. Cllr Keith Evans hoped that cameras could be placed on the wall facing the banks to identify the culprits.

Cllr Mike Hotson expressed his concerns that the traffic signs at Gorrig Crossroads needs replacing and that ground ruts adjacent to the bus shelter require attention.

### **Horeb**

Cllr Llyr Jones explained that he had seen the deeds for Maesgwyn, Horeb. He explained that the owner is happy for the bench to remain on the land as long as the Community Council regularly maintain it to an acceptable standard.
