- 1 **Ymweliad/Visit** – Cafwyd cyflwyniad gan Elen Grantham, Swyddog Galluogi Tai Gwledig, a chipolwg ar y gwaith gwerthfawr y mae hi'n ei wneud yng Ngheredigion. Mae ei swydd hi yn golygu creu pont rhwng y datblygwr a'r gymuned wrth iddynt ddarparu tai sy'n fforddiadwy ac ar gyfer pobl leol. Yn ogystal, dywedodd wrth y Cyngor Cymuned y byddai prosiect yn cael ei gynnal yn Llandysul a fyddai'n cynnig rhagor o dai. Gofynnodd hefyd a fyddai modd iddi ddychwelyd i weld y Cyngor gyda diweddariadau pan fyddai'r prosiect yn cychwyn. / Elen Grantham, Rural Housing Enabler gave a presentation and an insight into the valuable work that she is undertaking in Ceredigion. Her post is to bridge the developer with the community as they deliver housing that is affordable and for local people. She also told the Community Council that there would be a project in Llandysul that would offer more housing. She also requested that when the project would be underway that she come back to the Council with updates.

PCSO

Roedd PCSO Shan Davies yn bresennol yn y cyfarfod er mwyn rhoi diweddariad am y digwyddiadau yn Llandysul. Roedd 4 tocin goryrru wedi cael eu rhoi, cafwyd 3 galwad ynghylch ymddygiad gwrthgymdeithasol ac 1 achos o ddifrod troseddol. Unwaith eto, mae Llandysul wedi bod yn dawel. Atgoffwyd yr aelodau o'r ffaith y byddai'r Comisiynydd Troseddu yn y Ganolfan Ieuenctid ar 27 Chwefror am 1.15-1.15. Yn ogystal, gofynnodd PCSO Shan Davies i'r Cyngorwyr a oeddent yn ymwybodol o sŵn eithafol yn dod o gyfeiriad y Padlwr yn ystod y digwyddiad a gynhaliwyd ganddynt fis Hydref y llynedd.
