Minutes of Monthly Meeting of Cyngor Cymuned Llandysul Community Council held at Canolfan Ieuenctid Tysul Youth Centre, Llandysul, on 8 October 2012

Diolchodd Cyng Mrs Eileen Curry i Mr Dentten am fynychu'r cyfarfod a diolchodd hefyd i Gyng Keith Evans am gyflawni rôl y cadeirydd cyn iddi hi gyrraedd./ (Cyraeddodd Cynghorwyr Terry Griffiths a Breian Teifi yn ystod y cyflwyniad hefyd).
Community Health Council - Mr Sam Dentten attended the meeting and gave a report on prospective changes. There are cutbacks and changes are to take place. Concern was expressed by members as to the impact locally. We were encouraged to attend the consultation meetings. (Cllr Mrs Eileen Curry arrived at the beginning of the presentation and took over as chair. Cllr Mrs Eileen Curry also declared an interest).
Cllr Mrs Eileen Curry thanked Mr Dentten for attending the meeting and also thanked Cllr Keith Evans for presiding as chair until she arrived.
(Cllrs Terry Griffiths and Breian Teifi also arrived during the presentation).

C Cllr Peter Davies apologised for having to leave the meeting at 9.00am.

- 4 **Cofnodion/Minutes:** Derbyniwyd bod cofnodion y cyfarfod misol a gynhaliwyd ar 10 Medi 2012 yn gywir ac fe'u llofnodwyd gan y Cadeirydd/Minutes of monthly meeting held on 10 September 2012 were accepted as correct and signed by the Chair.

(Cyrhaeddodd Cyng Mrs Carolyn Reed-Rees cyn i'n busnes arferol gychwyn, gan ymddiheuro na fu modd iddi gyrraedd yn gynharach.)

5 Materion yn Codi: - Adroddwyd bod Ceredigion wedi delio gyda'r nyth cacwn ym Maesymeillion, heb godi tâl am wneud hynny. Pencampwriaeth Iau a Slalom Prydain 2012 – Roedd Cyng Tom Cowcher wedi cynrychioli'r Cyngor ac roedd wedi cyflwyno'r tlysau. Anfonir llythyr at y Ganolfan Geufad gan bod y digwyddiad wedi cael ei drefnu'n dda iawn a bu'n llwyddiannus iawn. Roedd busnesau lleol wedi cael cryn fudd o'r niferoedd da a wnaeth fynychu. Yn ogystal, adroddwyd bod unigolion wedi gwrthwynebu i'r digwyddiad ac y bu bron yn rhaid ei ganslo o ganlyniad. Cŵn yn y Parc – Mae Cyng Peter Davies a'r Clerc wedi cysylltu â Cheredigion, ond nid ydynt wedi cael ymateb. Fel Cynghorydd Sir, bydd Cyng Peter Davies yn trafod y mater parhaus gyda Cheredigion a bydd yn gofyn am gopi o'r is-ddeddf. Parcio yn Llandysul – Adroddwyd mai posteri Saesneg yn unig a ddangoswyd am gyfarfod a gynhaliwyd yn Llandysul ynghylch y cyfyngiadau amser er mwyn parcio ar y brif stryd a'r heol isaf. Yn ôl pob sôn, mae'r Cynghorydd Sir, Peter Evans, yn paratoi cynigion ar hyn o bryd. Gan nad oedd y Cyngor Cymuned wedi bod yn rhan o hyn, penderfynwyd anfon llythyr at Geredigion i wneud ymholiadau amdano. Mae Dŵr Cymru wedi cwblhau'r gwaith yn yr ardaloedd ym Mhont-siân ac yn Llandysul. Hen Gapel Llwynrhydowen – Cynhaliwyd cyfarfod ac mae dulliau posibl o godi arian yn cael eu hystyried.

 a) Carnifal Llandysul – (a145) Cafwyd anfoneb atodol mewn perthynas â'r grant o £500 y cytunwyd arno yn flaenorol a derbyniwyd y dylid anfon siec er mwyn talu'r swm.
 b) Sioe Llandysul – (a145) Cafwyd anfoneb atodol mewn perthynas â'r grant o £800 y cytunwyd arno yn flaenorol a derbyniwyd y dylid anfon siec er mwyn talu'r swm. Bu'n rhaid canslo'r brif sioe oherwydd y tywydd ond cynhaliwyd y cystadlaethau garddwriaethol a'r noson o adloniant.

5 Matters Arising: - It was reported that the wasps nest at Maesymeillion had been dealt with by Ceredigion without charge. British Junior and Slalom Championship 2012 – Cllr Tom Cowcher had represented the Council and presented the trophies. Letter of congratulations to be forwarded to the Canoe Centre as the event was very well organised and very successful. Local businesses had benefited significantly from the excellent turn out. It was also reported that the event nearly did not take place owing to individuals objecting. Dogs in the Park – Cllr Peter Davies and Clerk have contacted Ceredigion but, neither had received a response. Cllr Peter Davies as County Councillor will discuss the ongoing issue with Ceredigion and request a copy of the bye-law. Parking at Llandysul – It was reported that English only posters were displayed in connection with a meeting that has taken place at Llandysul in connection with the time limits on main street and lower road. Apparently, C Cllr Peter Evans is now developing proposals. As the Community Council was not involved, it was decided to send a letter of enquiry to Ceredigion. Welsh Water have completed the work in the areas of Ponsian and Llandysul. Hen Gapel Llwynrhydowen – Meeting has taken place and are looking into possible fund raising.
