YMWELIAD / VISIT

Roedd Dr Julian Evans, cynrychiolydd Calonnau Cymru, yn bresennol yn y cyfarfod er mwyn trafod diffibrilwyr a phwysigrwydd sicrhau eu bod wrth law ym mhob Cymuned. Pe byddai rhywun yn cael ataliad ar y galon, esboniodd y byddai gennych chi 4 munud i sicrhau bod y diffibriliwr yn cyrraedd y claf ac yna, byddai'r gyfradd lwyddo yn 80%. Esboniodd y byddai'n costio tua £1324 a bod ffurflenni cais ar gael i gymunedau ar wefan Calonnau Cymru. Hysbysodd y cyngor hefyd o'r angen i gael cyllideb wrth gefn pe bai'n prynu'r rhain, gan bod batri y peiriannau hyn yn para 5-7 mlynedd. Dywedodd hefyd y byddai ar gael i roi hyfforddiant am ddim pe byddai'r Cyngor Cymuned neu unrhyw gymdeithasau yn prynu peiriant. Diolchodd y Cadeirydd i Dr Evans am yr holl wybodaeth ac am fynychu'r cyfarfod.

Dr Julian Evans a representative from Heart Wales was present at the meeting to discuss defibrillators and the importance of all Communities having them to hand. He explained that if someone had a cardiac arrest you'd have 4 minutes to get the defibrillators to the patient and there was an 80% success rate. He explained that the cost would be around £1324 and application forms are available to communities on the Heart Wales website. He also informed the council the need of having a contingency budget if purchasing them as that the battery life was 5-7 years on the machines. He also said that he would be available to give free training if the Community Council or any associations were to purchase a machine. The Chairman thanked Dr Evans for all the information and for attending the meeting.

PCSO Shan Davies explained that she would be finishing her work mid March with the hope of returning to Llandysul after a year. She explained that there would be a replacement but was unsure of who at the moment.

It had been quiet in Llandysul over the Christmas period with 1 burglary behind a bar – which had resulted in an arrest and 1 asbo outside one of the public houses.

She explained that the Community Speed watch was still looking for Volunteers before the scheme could get underway.
