The annual Community Councils dinner would be held at Gwarcefel Arms, Prengwyn on the 25th of November. A menu was distributed to members and all were requested to return to the form with choices to clerk by the next meeting.

Planning

It was decided that the clerk liaise with the County's Planning Department in order to seek a better solution of giving the Community Councils' feedback on the planning applications. The clerk to report back at the next meeting.

Ward Matters

Pontsian Concern was expressed with regards to the state and maintenance of a public footpath between Allt Ddu and Meini Gwynion Bach. It was decided that Cllr Tom Cowcher contact the County Council to see who's responsible for the upkeep and maintenance of the path.

Maesymeillion and Prengwyn

Prengwyn village had been donated a defibrillator from Prengwyn Show and needed permission to site it in the Community Councils kiosk. Permission was granted. It was also decided to donate, in principal £300 to all wards within the Council who had a requirement for a defibrillator. All such requests would be considered as they are presented. Cllr Aled Jones informed the meeting that there were some grants available for Communities to obtain defibrillators, this information to be passed to the clerk for circulation.

Llandysul Cllr Keith Evans explained that some of the lights in the Carpark did not work.

Penderfynwyd y dylai'r clerc ysgrifennu at yr Adran Gwaith a Phensiynau er mwyn esbonio y byddai teithio yn peri problem i'r preswylwyr gan nad oes modd iddynt fanteisio ar y rhwydwaith trafnidiaeth yn hawdd, ac o ystyried y cysylltiadau agos rhwng y ddwy sir, gofynnir a fyddai modd trefnu rhywbeth yn lleol. Byddai DWP yn cael gwybod na fyddai modd i rai preswylwyr deithio er mwyn mynychu apwyntiadau ar adegau penodol yn ystod y dydd gan nad oes trafnidiaeth gyhoeddus ar gael. The Sports Society is in the process of making a grant application to the County Council for kitchen refurbishments. It was decided that the clerk provide a letter of support from the Community Council.

Cllr Keith Evans reminded members that the Gwyl Cerdd Dant was coming to the Area at Bro Teifi School on the 11th November. It was decided that the Community Councils pop-up would be displayed at the school but it was decided not to commission a Community Council flag.

The Church Warden had informed the Council that a tree in the church yard was very dangerous and had been reported to Ceredigion.

Cllr Abbey Reid explained that Carmarthenshire County Council would be changing to the Universal Credit system in March before Ceredigion would. Currently people can travel to the Job Centre Plus in Carmarthen to sign on, but the change in March would mean that the residents living in Ceredigion would have to travel to Cardigan or Aberystwyth instead.

It was decided that the clerk write to the Department of Work and Pensions explaining that travelling would become an issue for the residents as the transport network is not readily available for the residents and given how intertwined the two counties are, asking if something could be arranged locally. It would be highlighted to the DWP that some residents would not be able to travel to certain appointment times during the day as public transport is simply not provided.

It was also decided to contact Ceredigion County Councils Transport Unit to underline these problems.

Cllr Keith Evans explained that it was Library week and that a County wide effort was being undertaken to increase patronage. It was decided that the clerk write to Bro Teifi School asking for pupils to become members of the
