**Carnifal Llandysul**

Gofynnwyd am rodd o £1000 er mwyn helpu i redeg y carnifal blynyddol yn Llandysul. Ar sail costau 2023, byddai llogi'r Babell a chadeiriau a byrddau yn costio £2300 a byddai Yswiriant atebolrwydd cyhoeddus yn costio £300. Penderfynwyd rhoi'r swm y gofynnwyd amdano.

**Clwb Snwcer Llandysul**

Cafwyd cais am rodd o £400 gan Glwb Snwcer Llandysul er mwyn gwneud gwaith i drwsio'r wal ar dalcen yr adeilad er mwyn atal dŵr rhag dod i mewn. Penderfynwyd rhoi £400.

**Cymdeithas Chwaraeon Llandysul**

Atgoffwyd y Cyngor gan Gynghorydd Keith Evans o'r ffaith ei fod wedi cael goddefeb i siarad am a phleidleisio am y cais, fel y nodir uchod. Gofynnwyd am rodd o £5,000 mewn egwyddor tuag at brosiect a fyddai'n costio £50,000 gan y Gymdeithas Chwaraeon. Bydd y prosiect yn uwchraddio'r system dŵr poeth, bydd yn darparu toiledau

**Matters Arising: -**

**Defibrillator**

Cllr Sue Lloyd had registered the defibrillator at Rhydowen which had been procured from the Heart Foundation. They had confirmed that they did not have the resources to maintain the apparatus. Cllr Lloyd suggested that maybe the entertainment group in Pontsian might be able to maintain the batteries and pads.

**Llandysul Playarea**

Cllr Elen Grantham wished to reaffirm that she had no time at present to look for possible grants for the playarea in Llandysul.

**Car park Noticeboards**

The clerk to follow up finding a replacement supplier for the Perspex or acrylic front on the noticeboard in Llandysul Car Park Noticeboard.

**4) Funding Applications:**

**Llandysul Carnival**

A request for a donation of £1000 was requested for help with running the annual carnival in Llandysul. Based on 2023 costs the Marquee and table and chairs hire were £2300 and public liability Insurance £300. It was decided to donate the requested amount.

**Llandysul Snooker Club**

A request for a donation of £400 was received from Llandysul Snooker Club for repairs on the gable wall to prevent water ingress. It was decided to donate £400.

**Cymdeithas Chwaraeon Llandysul**

Cllr Keith Evans reminded the Council that he been given dispensation to speak and vote on the application as noted above.

A request for a £5k donation in principle towards a £50k project was asked from Cymdeithas Chwaraeon. The project will upgrade the hot water system, provide additional ladies toilets and installation of solar roof panels. The project will only proceed providing their application is successful in obtaining a grant from Cynnal y Cardi Uk Shared Prosperity
