2. **Election of Chair**:- Cllr Keith Evans proposed that Cllr Beth Davies remain as chair for the Municipal Year 2024/25 this was seconded by Cllr Peter Evans. There were no other nominations. As the elected chair Cllr Beth Davies thanked the Councillors and took chairing the meeting.

The meeting was advised that Cllr Howell had advised Clerk that he did not wish to be considered for the role. Cllr Gethin Jones was proposed by Cllr Peter Evans and seconded by Cllr Heddwyn Davies and carried.

Continued delegated authority was given to the Clerk to deal with the applications between meetings by contacting the relevant members.
5. **Election of Finance Committee** It was resolved to elect the following to the Finance committee: - Cllrs Beth Davies, Keith Evans, Sue Lloyd and Mike Hotson.
Cllrs Keith Evans and Andrew Howell and Douglas Davies would remain as Cheque signatories.
6. **Internal Auditor** It was resolved to ask Mr R J Foulkes to continue as Internal Auditor.
7. **Internal Control/Internal Checker**:- It was resolved that Cllr Gethin Jones undertakes the tasks of Internal Control/Internal Checker.
8. **Risk Assessment** Appropriate steps to manage Internal Control/Risk Assessment and review of Insurance have been taken.
9. **To Receive Statement of Accounts** Cllr Gethin Jones proposed, seconded by Cllr Douglas Davies that we accept the Accounts as a true record. This was unanimously agreed.

Members were also reminded that they could apply and seek dispensation to Ceredigion's Ethics and Standards committee if they so wished. Declarations of interest were provided by Cllrs Beth Davies and Gethin Jones regarding the request for donation from Llandysul Show
