Ymhelaethodd Cynghorydd Keith Evans ar gynigion cyllideb Ceredigion, a'r ffaith bod y Cyngor llawn wedi cytuno arnynt yn ystod ei gyfarfod ar 2 Mawrth 2026, a bod ei gais ef am gyllid refeniw o £30,000 y flwyddyn i Galon Tysul wedi cael ei gefnogi. from the County Council asking if we would like to re-submit an application for children's play equipment that had sent in in June. The Grant application had now been successful for the sum of £12,150.
